Boarding School Tuition and Fees

Tuition*

Tuition for boarding students is \$12,000 per academic year and includes the following:

*Tuition and fees are non-refundable and non-transferable. A 10% fee is automatically assessed for all past due accounts and returned checks.

Payment Options

Two (2) payment options are available for boarding students:

- **Option 1:** Two (2) semester installments of \$6,000 each, payable by the first day of August and January
- **Option 2:** Four (4) quarterly installments of \$3,000 each, payable by the first day of August, October, January, and March

Statement of Faith

- A. The Scriptures. The Bible is the inspired Word of God, the product of Holy Men of old who spoke and wrote as they were moved by the Holy Spirit. The New Covenant, as recorded in the New Testament, we accept as an infallible guide in matters pertaining to conduct and doctrine. (II Timothy 3:16; I Thessalonians 2:13; II Peter 1:21).
- B. The Godhead. Our God is one but manifested in three persons – The Father, the Son, and the Holy Spirit (Philippians 2:6 and Matthew 3:16-17). God the Father is greater than all; the Source of the Word (Logos) and the Begetter (John 14:28; John 16:28; John 1:14). Jesus is the Son of God, One with the Father, the Word flesh-covered, the One Begotten, and has existed with the Father from the beginning (John 1:1; John 1:18; John 10:30). The Holy Spirit proceeds from both the Father and the Son and is eternal (John 15:26).
- C. Man, His Fall and Redemption. Man is a created being, made in Likeness and image of God, but through Adam’s transgression and fall, sin came into the world. “All have sinned and come short of the glory of God.” “As it is written, there is none righteous, no not one.” Jesus Christ, the Son of God, was manifested to undo the work of the devil and gave His life and shed His blood to redeem and restore man back to God (Romans 5:12; Romans 3:9-10; I John 3:8; Galatians 3:13-14). Salvation is the gift of God to man, separated from works and the law, and is made operative by grace through faith in Jesus Christ, producing works acceptable to God (Ephesians 2:8).
